- III. Introduction of new Board member Elizabeth Stanley
- IV. Finance Team report
  - A. Ron reported that January was a good month for income
  - B. Ron proposed a motion to authorize the Finance Team to move money from the checking account into the investment account at Schwab, leaving a minimum of \$150,000 in the checking account at all times
    - 1. This would allow the church to benefit from the current strong performance of the investment account
    - 2. Passed unanimously
- V. Status of Discernment Team Action Items
  - A. Dan led us through a review of the remaining action items that resulted from the Discernment Teams
  - B. Conversation with Conference concerning materials on website
    - 1. Laura sent email to congregation 1-31-2023 summarizing the conversation with the Conference expressing concern with materials posted on Conference website
    - 2. Dan were there reactions to that email from the congregation?
    - 3. Laura not really
  - C. Clarifying relationship between our congregation and Conference, our independence
    - 1. Part of the goal of the presentation on the Book of Discipline March 5
    - 2. Ron can the session be recorded to share?
  - D. Dan are we therefore done with the action items from the discernment process?
    - 1. Consensus yes, we are done
- VI. Values, Vision and Mission
  - A. Dan reminded us that the focus of our next meeting will be to finally move on the developing mission, vision, values statements
  - B. Provided us with handout
    - 1. Definitions of mission, vision, values from Kim
    - 2. Examples of each from previous congregation materials
  - C. Dan, Kim and Laura will work out a process for the March 12 meeting
    - 1. Kim start with values first, then move on to other two
    - 2. No need to involve third party
  - D. Thoughts on mission, vision, values
    - 1. Jack need to focus on the future, where we want to go, not where we've been
    - 2. Jack one of the desired purposes of the new leadership structure was to focus on future rather than being reactive to the past
    - 3. Dan—need to be high-level
    - 4. Susan need to be focused on communicating to the congregation, who may not be long-term church goers
  - E. How to promulgate mission, vision, values to the congregation
    - 1. Kim suggested format "Based on your feedback, this is what we heard. Did we get it right?"
    - 2. Laura suggested making ourselves available for a doughnut hour on Sunday
    - 3. Support for more frequent celebrations similar to the thank-you lunch coming up or the chili cook-off
  - F. Once mission, vision, values in place, will serve as guidelines for the Senior Pastor and staff in developing goals for the year
